Regs4ships provides access to live and archived regulatory publications from the IMO, ILO, and numerous flag states. Available via web browser for Onshore or integrated within the OneOcean Platform for Onboard, it allows seamless online and offline use. Leaders aboard can view regulatory data in context with voyage variables, streamlining workflows and ensuring compliance.





Monitor regulations before and during voyage with data on over 78,000 environmental zones, 182 nations. This ensures clarity of all environmental regulations on route and that you have the discharge waste stream type for your vessel. Environmental standards can be set and deployed from one location across fleets.



Create an accurate audit trail to maintain QHSE compliance and accountability with the Accident and Incident Reporting module (Docmap). LR OneOcean's Electronic Record Books module (LogCentral) also offers a consistent and digital way to record and maintain logbook entries.
